The Planning Department had tentatively assumed the 12th Plan size at Rs.195816.00 crores (at 2011-12 prices) and prepared 12th Plan schemewise details at the time of preparation of Annual Plan 2012-13. The approval of Planning Commission for broad sectoral allocations of the 12th Plan is yet to be received. However, recently the Planning Commission had brought out 12th Plan document, wherein the plan size for Karnataka had indicated at Rs.255250.00 crores (at current prices). Further, the Planning Commission had also given broad sectoral allocations in the same document and said that the State Government may change the allocations proposed by the Planning Commission.

In the 57th NDC meeting held on 27.12.2012 for approving the 12th Plan document of GoI, the State Government had also made a request to the Planning Commission to allow the State Government to change these sectoral allocations within the plan size based on the priorities of the State Government.

Accordingly, the State Government had worked out the broad sectoral allocations of the 12th Plan as per the priorities of the State Government and indicated in the annexure enclosed to this letter. It is therefore requested that the Planning Commission may give its approval for broad sectoral allocations of the 12th Plan as given in the annexure at the earliest.
